

# Father's Day Contest Official Rules

NO PURCHASE NECESSARY. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

**WHO CAN ENTER:** The Florida Panthers Father's Day Contest ("Contest") is open to only to legal residents of Florida, 18 years of age or older. VOID WHERE PROHIBITED.
